**Consumer Privacy Policy with Opt-Out Notice**

This document is your notice of our policies regarding your nonpublic personal information that you give us in connection with your loan, including your right to opt out of the disclosure of nonpublic personal information to nonaffiliated third parties by completing and returning the form below. Federal law allows you to limit some, but not all sharing.

**WHY?** As a normal part of business, we gather nonpublic personal information from the following sources:

- **Information we receive from you when you fill out an application.**
- **Information about your transactions with our company.**
- **Information obtained from consumer reporting agencies.**

**WHAT?** We may give out the following types of nonpublic personal information:

- **Information we receive from you when you apply for a loan at our company.**
- **Information about your transactions with our company, such as payment history.**
- **Information obtained from consumer reporting agencies, such as credit history.**

**HOW?** We may give out nonpublic personal information about you to nonaffiliated third parties as permitted by law and for everyday business purposes, such as to process transactions, maintain accounts, respond to court orders or report to credit bureaus:

- **Financial service providers, such as other lenders.**
- **Nonfinancial companies, such as direct marketers who perform services on our behalf.**
- **Persons you expressly authorize to access your information.**

**WE PROTECT YOUR INFORMATION:** We do not give out nonpublic personal information, except as permitted by law. We use security measures to safeguard your personal information and restrict access to only our employees who transact business with you. We follow policies that comply with federal law to protect the confidentiality of your nonpublic personal information.
